## **OLD BUSINESS:**

## MEDICAL OVERTIME ARBITRATION

Medical Overtime Arbitration resumed March 4-5 2016. Warden Holland and Little have spoken on this medical overtime issue. Warden Holland stated that if he saw this as a clear violation he would engage in settlement talks. President Little gave him our amount to start negotiation. He in turn gave us his counter. We are hopeful that we may be able to settle instead of going for an award.

## **CORRECTIONAL SERVICES OVERTIME ARBITRATION**

We are awaiting a decision from arbitrator. Settlement agreement may be out of the question due to other locals' involvement.

#### **CME ARBITRATION**

CME hearing has been completed. Cheryl is getting together a brief. We are awaiting a decision.

## PIV CARDS

A notice should have been sent out complex wide to staff. If you came in on your own time to get your PIV card or password. Submit your name and some type of compensation will be awarded.

## **SHOE MOBILE**

Agreement has been negotiated to go back to 2013. Staff will be issued 2 pair of shoes and after than every 9 months. Once this has been done you need to go pick up your shoes every 9 months.

## LOCAL AND GLOBAL PII

AFGE has just assigned representative for all federal employees. AFGE will be filing a grievance. AFGE will be going to arbitration for the entire government workers under AFGE. Locally we have already filed a grievance. FCI has already won their case. Agency is trying to negotiate a settlement for the whole complex. Warden Holland says he is open to settle the local grievance.

## AFGE MARCH

On February 13<sup>th</sup> we had an AFGE March. Anderson, Cheryl, Ms. Harris, Little along with some AFGE members in Raleigh to participate in the march. President Little is asking of the

body that when AFGE has these marches. We really need Local 0408 to come out and participate. These marches are representing our jobs and benefits. AFGE can't do it alone. We need support from our body as well. Please keep that in mind when we put these request out for future marches.

## MEDICAL BIDDING

Right now, Daniel is in the Washington testifying on the national arbitration about PHS and Civil Service bidding. Testifying on how the Lab has held back civil service positions. The Warden Holland stated that he would like for us to bid. One of the reasons that the medical bidding did not go through under Warden Atkinson. The way he was acting and the trickery surrounding his actions of under handed acts. So Pres. Little decided not to go forward with the bid. Warden Atkinson probably wanted to split the roster. Once something is done it is a lot harder to undo.

## STEWARDS TRAINING

We will be having stewards training as soon as ART is over. The stewards will be placed over different departments.

## DCT TRYOUTS

Certain people were attempting to have an unauthorized test for DCT. This test was not sanctioned by the nationals. This was something someone came up with on the DCT Team to try and weed out certain people. Talked this over with management and the test is out.

That is still in settlement talks. Our attorney stated that they have settled every other portal case except ours. Ours was not settled due to the illness of one of the Agency attorneys.
